RDNs or international equivalents should advise adult clients with overweight or obesity that many different dietary patterns can be individualized to support client- centered goals. Prescribed dietary approaches should achieve and maintain nutrient adequacy and be realistic for client adherence. Prescribed calorie levels should be tailored based on estimated or measured needs and should be adjusted to improve weight outcomes, as appropriate for and desired by each client.	1C	Intervention details, including prescribed dietary intake, were extracted for each study included in the supporting systematic review. <sup>66,67</sup> Dietary advice was described in 74% of included studies.
